

Terms and Conditions for CAs Online

Welcome to CAs Online, an online recruitment platform owned and operated by Blue Recruiting. By accessing or using this platform, you agree to comply with the following Terms and Conditions. Please read them carefully.

1. Intellectual Property and Protection Against Duplication

- 1.1. **Ownership:** All content, design, data, software, and intellectual property on the CAs Online platform are owned by Blue Recruiting and are protected by copyright, trademark, and other intellectual property laws.

- 2.3. **Existing Agreements:**
 - 2.3.1. If you have a pre-existing, signed recruitment agreement with Blue Recruiting, the recruitment fee specified in that agreement will apply to any placements made through CAs Online.
- 2.4. **No Existing Agreement:**
 - 2.4.1. In the absence of a pre-existing signed agreement, Blue Recruiting will negotiate a recruitment fee with you (the employer) for any candidate hired through CAs Online.
 - 2.4.2. The recruitment fee will be 20% of the candidate's first-year total compensation package (inclusive of salary, bonuses, and any other benefits).

- 2.4.3. Blue Recruiting will invoice the employer upon confirmation of the candidate's employment, and payment will be due within 30 days of the candidate's start date unless otherwise agreed in writing.

3. User Obligations and Acknowledgment

- 3.1. **Binding Agreement:** By using CAs Online, you acknowledge and agree that any introduction made through the platform is binding for recruitment purposes and that the terms of recruitment outlined in this document will apply.
- 3.2. **Compliance with Laws:** Users of the platform agree to comply with all relevant employment, recruitment, and privacy laws in their jurisdiction when using CAs Online.

4. Confidentiality

- 4.1. **Candidate Information:** Any candidate information shared on CAs Online is confidential and must be used solely for recruitment purposes.
